**1. BRIEF OVERVIEW OF HOW THE “BON-TON® MILLION ACTS OF GOODWILL INSTANT WIN GAME & SWEEPSTAKES” PROMOTION WORKS:** The Promotion consists of an Instant Win Game ("Game") and Sweepstakes ("Sweepstakes") that start February 22, 2012 at 12:00 AM Eastern Time ("ET") and end March 22, 2012 at 11:59:59 PM ET ("Promotion Period").
